

WORLDSTRIDES \$1,000 TRAVEL VOUCHER CONTEST OFFICAL RULES

Contest Sponsor: WorldStrides is the sponsor of the \$1,000 travel voucher contest ("Contest") being held on worldstrides.com.

Eligibility: This Contest is open only to individuals ("Entrants") who are permanent residents of the United States of America. Entrants, or individuals featured in an entry, must be 14 years of age or older as of the date of entry. If a submission sent in by an Entrant features an individual under the age of 18, the Entrant must be the legal guardian of that individual. Written parental consent will be required for persons under 18 (or who are not of the age of majority in their state of domicile) for their entries to be considered. To be eligible to win the Prize, entries must be completed and received by WorldStrides as described below. Directors, officers, and employees of WorldStrides and any of its affiliated and successor companies, its or their professional advisors, advertising and promotional agencies, and Contest partners and prize suppliers, and immediate family members of any of them, are not eligible to participate. "Immediate family members" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws", or by current or past marriage, remarriage, adoption, co-habitation or other familial extension, and any other persons residing at the same household location, whether or not related. All applicable federal, state and local laws and regulations apply. Contest void where restricted or prohibited by law.

Contest Period: The Contest shall commence on October 1, 2017 and shall end on November 1, 2017 at 12:00 p.m. EST (the "Contest Period"). All entries must be received during the Contest Period to be eligible to win the Prize. Any entries not received during the Contest Period will not be eligible, and such entries will not be considered. WorldStrides also reserves the right in its sole discretion to suspend or cancel the Contest or any Entrant's participation in the Contest should causes beyond the control of WorldStrides corrupt the administration, security or proper play of the Contest or if WorldStrides otherwise becomes (as determined in its sole discretion) incapable of running the Contest as planned.

Prizes: One winner will be selected at random to win a \$1,000 travel voucher which is redeemable for \$1,000 in airline tickets. Some restrictions may apply. No substitution or exchange of Prizes or cash payment in lieu thereof will be permitted, except that WorldStrides reserves the right to substitute a prize of equal or greater value for a Prize or any portion thereof. Prizes are not assignable or transferable.. PRIZES WILL BE AWARDED "AS IS" AND WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, (INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE).

How to Enter: NO PURCHASE NECESSARY. To enter fill out all required form fields on worldstrides.com

Entries: Use of any automated system or agent to submit entries is prohibited and will result in disqualification. In the event of a dispute as to any entry, the authorized account holder of the e-mail address used to enter will be deemed the Entrant. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail for the domain associated with the submitted address or account. Potential winners may be required to show proof of being the authorized account holder. The winner must submit the web form in order to receive his or her prize. Only the email user who received the email at his/her email address is eligible to win the prize. Multiple submissions are not allowed, and the prize may be revoked if a user is deemed to be manipulating the contest entry.

Selection of Winners: After the conclusion of the Contest Period, WorldStrides will select one (1) travel voucher winner, to be selected at random, subject to verification of selected winners' eligibility. Verification of eligibility will be in the sole and absolute discretion of WorldStrides whose decisions will be final.

Release and Affidavit: All Entrants release WorldStrides and its affiliated and successor corporations, their directors, officers, shareholders, employees and other agents, professional advisors, advertising and promotion agencies, Contest partners and Prize suppliers, from and against all claims and damages arising in connection with the Entrant's entry and/or participation in the Contest and/or his or her receipt or use of any prize awarded in the Contest. As a condition to being awarded a Prize, the winner will be required to execute and deliver to WorldStrides a signed Affidavit of Eligibility, which includes an acceptance of these Contest Rules and a certification of age and residence, and a release of liability. A legal guardian must sign the Release forms for minors.
